## The Good Intent of the Administration of Bansobkorn School

Bansobkorn School is currently focused on the management of ethical practices under the Good Governance Framework according to the ordinance, "On the Rules and the Method of Good Governance of the Country" (2003) the Twelfth National Economic and Social Development Plan (2017-2021), the National Anti-Corruption Strategy – Phase 3 (2017 – 2021), and government policy (General Prayut Chan-ocha )gave the Statement of Policy to the National Legislative Assembly on September 12, 2014, in order to encourage the Government Administration to adhere to good governance practices and to investigate corruption and misbehavior in the government. The Civil Service Code of Ethics (2009), sector Code of Ethics for Civil Servants (2009), and the Integrity and Transparency Assessment (ITA) of the Office of the National Anti-Corruption Commission (NACC) and of the Office of Public Sector Anti -Corruption Commission (PACC).

As the The director of Bansobkorn School, I would like to formally announce my legal requirement to ensure that all governors and staff perform their work with morality, integrity, efficiency, and effectiveness. We are ready to protect the interests of the government and ensure fairness, equality, and justice for our stakeholders.

On behalf of Bansobkorn School , we would like to announce our intention to operate with honesty, transparency, and accountability in our governance; to build confidence in Nan that the Nan Primary Educational Service Area Office 2, we will fight corruption in all forms. We intend to do so with the following guidelines:

- 1. Perform all procedures in accordance with all applicable laws and regulations, as well as encourage personnel to comply with these laws and regulations.
- 2. Raise awareness of corruption. Educate Nan about the benefits of stopping corruption. Cultivate moral awareness about corruption, and fight corruption at all levels of governance effectively, and with all personnel involved.
- 3. We will not accept corrupt behavior and will not tolerate any form of corruption.
- 4. We will promote transparency at all levels of governance, and when appropriate in the private sector. Disclose information about all activities.

- 5. Create a culture of good governance. Investigate and prosecute cases of fraud and corruption.
- 6. Operational Guidelines and Collaborative Activities.

6.1 Coordinate and collaborate with various agencies in the implementation of National Anti-Corruption Strategy Phase 3 (2017 – 2021)

6.2 Join the Anti-Corruption network between the Office of the Nan Primary Educational Service Area Office 2.

6.3 Provide knowledge about national strategies to combat corruption, specifically National Anti-Corruption Strategy Phase 3 (2017 – 2021). Build awareness and promote participation in educating our students, their parents, and the general public about participating in anti-corruption activities.

6.4 Promote healthy public relations and communicate the implementation of the AntiCorruption Cooperation Network.

6.5 Take any other action necessary, with any agency necessary.
